In addition to the statement, the Prospective Bidders must attach a copy of any of the following documents: contract, certificate of completion, Official Receipts or any other document which must show the contract amount.
- 6. **Criteria for Evaluation/Dimension of Performance**. The NTA-BAC shall publish the criteria/dimension for evaluation as part of the Bid Bulletin.
