PROCEEDINGS

1. The BAC Chairperson officially called the Pre-bid Conference to order at 10:10 a.m., with the presence of the four (4) BAC Members, the COA Representative, the TWG staff, and the lone prospective bidder, who have not yet purchased bidding documents. However, the BAC allowed him to ask clarificatory questions, despite non-payment of the bidding fee.
2. The BAC Chairperson announced that the Pre-bid Conference is in compliance with the 2016 Revised Implementing Rules and Regulations under R.A. No. 9184, and proceeded to state the Contract Name of the Project to be bid-out and the ABC for the project, and informed the body that this conference was being held in order for the bidder to be enlightened and be able to clarify issues/ concerns regarding the project, followed by the introduction of the BAC Members and the COA Witness.
3. The BAC Chairperson allowed and encouraged Mr. Serafica, representative of Hino Motors Phils., to make queries on the said project.

4. Mr. Serafica instead of asking questions commented and offered the following suggestions specific on the Hauling Truck, to wit:
 - Displacement of 3.0L be made into a minimum of 3.0L, which he informed is most beneficial; even specifically mentioning the range be: minimum of 3.0L but not exceeding 7.0 liters
 - Adopt a Manufacturer's Standard that the prospective bidder can offer instead of requiring specifically an Auto Door Lock and Power Window
 - The set specifications are limited to refer to only a particular brand.
5. The BAC Chairperson informed that with all of the above suggestions of the prospective bidder, the BAC will issue Bid Bulletin in clarification of the technical specifications of the project.
6. There being no questions/matters to address, the Pre-bid Conference was adjourned at 10:30 a.m.
