



INVITATION TO BID FOR: SUPPLY AND DELIVERY OF FERTILIZER, CPA AND SUCKERCIDE REQUIREMENTS FOR USE IN IFOIGAP – TOBACCO (TCGS) CY 2020-2021 FOR NTA CANDON, ISABELA AND CAGAYAN BRANCH OFFICES (PB 2020-07)

1. The National Tobacco Administration (NTA), through its Corporate Operating Budget for FY 2020, intends to apply the total sum of **PhP45,972,170.00**, with PB No. 2020-07, being the ABC to payments under the contract. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The NTA now invites bids for the above Procurement Project. Delivery of the Goods is required by *fifteen (15) days, from receipt of Notice to Proceed*. Bidders should have completed, within three (3) from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
 - b. Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.
4. Prospective Bidders may obtain further information from NTA and inspect the Bidding Documents at the address given below during 8:00 am to 5:00 pm, except Fridays, Saturdays, Sundays and Holidays.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **October 13 to October 28, 2020**, from the given address and website(s) below, *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of PhP25,000.00*.
6. The NTA will hold a **Pre-Bid Conference on 20 October 2020; 10:00 a.m.** at *NTA Training Room, 4th Floor, Ben Lor Building, 1184 Quezon Avenue, Quezon City*, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before **29 October 2020, 5:00 p.m.** Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14.**
9. Bid opening shall be on **02 November 2020; 10:00 a.m.** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The NTA reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
