## INVITATION TO BID SUPPLY AND DELIVERY OF FERTILIZER REQUIREMENTS FOR IFOIGAP – TOBACCO, (TCGS), CY 2019-20 (PB 2019-06)

1. The NATIONAL TOBACCO ADMINISTRATION (NTA), through the 2019 Corporate Operating Budget intends to apply the sum of PhP 39,691,408.00, being the Approved Budget for the Contract (ABC) to payments under the contract for the project: "Supply and Delivery of Fertilizer Requirements for IFOIGAP – Tobacco (TCGS), CY 2019-20", broken down into five (5) lots, as follows:

Lot 1 (Abra)

Lot 2 (Ilocos Norte)

Lot 3 (Candon - Ilocos Sur)

Lot 4 (La Union)

Lot 5 (Pangasinan)

Bids received in excess of the ABC shall be automatically rejected at bid opening.

- 2. The NTA now invites bids for the supply and delivery of fertilizer requirements for IFOIGAP Tobacco. Delivery of the Goods is required for a period of **fifteen (15) days**. Bidders should have completed, within a period of five (5) years, from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
  - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
  - (ii) Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.

A complete set of Bidding Documents may be acquired by interested Bidders beginning on 5. October 01, 2019 to October 21, 2019, from the address below; and upon payment of the bidding fees for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the following amount, to wit:

- The NTA will hold a Pre-Bid Conference on **08 October 2019**, at **10:00 a.m.**, at 4<sup>th</sup> Floor, 6. Training Room, 1184 Ben Lor Building, Quezon Avenue, Quezon City, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat at the address below on or before 21 October 2019. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on 21 October 2019, at 10:00 a.m., at 4th Floor, Training Room, 1184 Ben Lor Building, Quezon Avenue, Quezon City. Bids will be opened in the presence of the bidders' representatives, who choose to attend at the address below. Late bids shall not be accepted.

- The NTA reserves the right to reject any and all bids, declare a failure of bidding, or not 8. award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
