CONTRACT AGREEMENT

THIS AGREEMENT, made this 28th day of December 2017, between **NATIONAL TOBACCO ADMINISTRATION**, Cors. Scout Reyes Street and Panay Avenue, Quezon City, hereinafter called the "Entity", and **WCD International Trading Corporation**, with office address at Suite 204 Sunrise Condominium, Ortigas Avenue, Greenhills, 1502 City of San Juan, Metro Manila, hereinafter called the "Supplier".

WHEREAS, the Supplier was an eligible bidder, who submitted its bid proposal for the Project: "**Relocation, Annual Preventive Maintenance and Replacement of Parts of One (1) Unit Smoking Machine (SM450)**", with Contract Identification No. PB 2017-09, hereinafter called the "Goods", and was declared as the Single Lowest Calculated and Responsive Bid (SLCRB), in the amount of **Three Million, One Hundred Sixty Thousand, Three Hundred Thirty-Six Pesos and Sixty Four Centavos (PhP3,160,336.64)**, inclusive of VAT, offered by the Supplier for the delivery of such Goods, for a period of fifteen (15) days, and the remedying of any defects therein, effective thirty (30), upon receipt of the Notice to Proceed.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectfully assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - a) General and Special Conditions of Contract;
 - b) Specifications;
 - c) Invitation to Bid;
 - d) Instructions to Bidders;
 - e) Bid Data Sheet;
 - f) Addenda and/or Supplemental/Bid Bulletins, if any;
 - g) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
 - h) Eligibility requirements, documents and/or statements;
 - i) Performance Security;
 - j) Notice of Award of Contract and the Bidder's conforme thereto; and
 - k) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to deliver and install the Goods and remedy any defects therein in conformity with the implementation of this Contract in all respects.

4. The Entity hereby covenants to pay the Supplier in consideration of the delivery and installation of the Goods and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at all times and in the manner prescribed by this Contract, and all pertinent documents attached herewith.
