C. REQUEST FOR ADDITIONAL FUND FOR THE REPAIR OF THE NTA BATAC BRANCH AND FTSD OFFICES, BATAC CITY, ILOCOS NORTE, BASED ON THE REVIEW, RECOMMENDATION AND CERTIFICATION OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) STANDARDS

For consideration and approval by the NTA Governing Board is the request of the NTA Management to use the amount of Php152,574.91 from certain items under the Capital Outlay of the DBM-Approved Corporate Operating Budget for FY 2018 as additional funds for the repair of the NTA Batac Branch Office based on the revised Agency Program of Work pursuant to the review, recommendation and certification from the Department of Public Works and Highways (DPWH), in addition to the previously approved amount of Php3,834,696.16.

E. AMENDED IMPLEMENTING GUIDELINES FOR THE INTEGRATED FARMING AND OTHER INCOME GENERATING ACTIVITIES PROJECT – TOBACCO CONTRACT GROWING SYSTEM (IFOIGAP-TCGS)

Dir. Salanga moved for the approval of the matter. Dir. Quintal seconded the motion. The board then adopted the following resolution, to wit:

D. STRICT IMPLEMENTATION OF THE 2018 REVISED RULES AND REGULATIONS GOVERNING THE TRADING AND REDRYING OF LOCALLY GROWN LEAF TOBACCO

Dir. Salanga reminded Atty. Ambros to strictly implement the 2018 Revised Trading Rules, particularly the provision requiring the submission of duly signed and notarized Marketing Agreement, Purchase Commitment and posting of Financial Guaranty and Performance Bond by all Tobacco Buying Stations and Wholesale Tobacco Dealers in the renewal of their respective licenses/Permits.

Dir. Salanga said that the submission of the said requirements will avoid pole vaulting in the trading of tobacco.

Dir. Casela also added that the Marketing Agreement should include a provision on the strict adoption of Good Agricultural Practices (GAP) and undertaking to follow the unified production technology.
