## C. AUTHORITY TO IMPLEMENT THE FOURTH TRANCHE OF SALARY ADJUSTMENT PURSUANT TO EXECUTIVE ORDER NO. 36, S. 2017

For consideration of the NTA Governing Board is the request of NTA Management to implement the 4<sup>th</sup> Tranche of Salary Adjustment pursuant to Executive Order No. 201, S. of 2017. During yesterday's committee meeting, Ms. Laudencia informed the board that the Department of Budget and Management (DBM) issued Corporate Budget Circular No. 23 dated January 15, 2019 authorizing the implementation of the fourth tranche compensation adjustment for GOCCs covered by the DBM.

Ms. Laudencia further informed the members of the board that the NTA previously requested from the Governance Commission for GOCCs (GCG) for authority to implement the salary adjustment pursuant to GCG Memorandum Circular No. 2017-03 with the subject: "Implementing Rules and Regulations of Executive Order No. 36, S. of 2017". The said implementing guidelines provides for the salary adjustments for CY 2017, 2018 and 2019 as provided in Sections 8.1, 8.2 and 8.3 thereof, respectively. Atty. Ambros added that the GCG authorized the NTA to adopt the Compensation Framework under EO 36, as per its letter dated 28 September 2017. Ms. Laudencia said that the total budgetary requirement to implement the salary adjustments is about Php20 Million for CY 2019.

Dir. Casela requested for the deferment of the matter for consideration in the next board meeting. However, Dir. Quintal moved for the approval of the request. Dir. Casela then requested for the division of the house and vote whether to allow NTA management to implement the 4<sup>th</sup> tranche of salary adjustment.

On motion of Dir. Quintal, duly seconded by Dir. Salanga, the NTA Governing Board adopted the following resolution, to wit:

"BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the NTA Governing Board approves the request of the NTA Management to implement the Fourth Tranche of Salary Adjustments for CY 2019 pursuant to GCG Memorandum Circular No. 2017-03 with the subject: "Implementing Rules and Regulations of Executive Order (E.O.) No. 36, s. 2017".

## E. REVISED PROJECT PROPOSAL FOR THE SOUTHERN MINDANAO TOBACCO PILOT PRODUCTION PROJECT

During yesterday's committee meeting Ms. Laudencia reacted to the revised project proposal considering that there is an increase of budgetary requirement and the NTA is authorized to undertake project within the level of FY 2018 COB only.

Dir. Salanga also said that the board will have to review the proposal and moved for the deferment of the matter until the budget for FY 2019 is approved. However, he said that NTA will stick to the Php942,000.00 original budget for the project.

Dir. Trongco likewise reported the consultation dialogue they had with Datu Randy of Saranggani. He said that as per his own assessment, the project will become productive with the help of the NTA and support from the group of Datu Randy, but he said the NTA should wait for the result of the demo farm after six (6) months.

Dir. Salanga moved for the deferment of the matter. Dir. Casela seconded the motion. The board then adopted the following resolution, to wit:

#### **RESOLUTION NO. 1007-2019**

"BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the NTA Governing Board defers the Revision of the Project Proposal for the Southern Mindanao Tobacco Pilot Production Project and to stick with the budget as originally submitted subject to further review of the matter when the budget for FY 2019 is already approved.

#### IV. OTHER MATTERS

A. DECISION OF THE COURT OF APPEALS IN THE CASE INVOLVING THE NTA PROPERTY AT BO. PUGAD LAWIN, LAS PIÑAS CITY

During yesterday's committee meeting, Atty. Roberto M. Sison, Attorney V, reported that the Court of Appeals rendered a decision in the appeal of the Ayala Land Inc. on the decision of the Regional Trial Court Branch 275 – La Piñas City. He said that the CA granted the appeal of Ayala Land

Inc. and remanded the case to the court of origin for further proceedings. Atty. Sison also said that there was already as Supreme court decision declaring that the survey plans used by Ayala as basis of its claim over the subject property was declared void, including the certificate of titles issued on the basis thereof. He said that the CA failed to recognize the SC decision and this can be a basis to file a Motion for Reconsideration. He then asked the board for authority to file a MR.

On motion of Dir. Casela, duly seconded by Dir. Quintal, the board adopted the following resolution, to wit:

"BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the NTA Governing Board hereby authorized the NTA Management, through the NTA Legal Counsel, to file a Motion for Reconsideration on the decision rendered by the Court of Appeals involving the NTA property located at Bo. Pugad Lawin, Las Piñas City.

## B. AMENDMENTS OF THE IMPLEMENTING GUIDELINES FOR THE CURING BARN ASSISTANCE PROJECT (CBAP)

Yesterday, Dir. Salanga recalled that he previously requested the 2017 list of farmers who were granted CBAP loans but availed only the free portion. He said that it was the intention of the board that those farmers shall be disqualified from availing future CBAP loans. Ms. Estrella G. de Peralta reported that some of those farmers were already granted and received new CBAP loans. Ms. Minerva P. Mizal also said that she was not aware of such disqualification and it was not specifically mentioned in the implementing guidelines. Ms. De Peralta and Ms. Mizal then proposed that these farmers will pay their previous CBAP loans and continue with their existing loans.

On motion of Dir. Salanga duly seconded by Dir. Casela, the board adopted the following resolution, to wit:

#### **RESOLUTION NO. 1009-2019**

"BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the NTA Governing Board approves the further amendment of the Implementing Guidelines for the Curing Barn Assistance Project (CBAP) that the Farmer-Availees who have previously availed of the free portion only of the CBAP assistance granted in CY 2017 are still qualified to avail for new CBAP loan; *Provided*, that they shall repay fifty percent (50%) of the amount of the free portion received from their previous availment payable within a period of one (1) year starting Crop Year 2018-2019 until Crop Year 2019-2020, with two percent (2%) interest from date of availment.



#### UNANIMOUSLY APPROVED......"

Also, there were confusions encountered by the NTA Branch Offices with respect to the grant of calamity assistance to farmers affected by Typhoon Ompong vis-à-vis availment of CBAP loans. It was clarified that the calamity assistance is entirely separate and distinct and receipt of calamity assistance is not deductible from the CBAP loans.

On motion of Dir. Salanga duly seconded by Dir. Casela, the board adopted the following resolution, to wit:

#### **RESOLUTION NO. 1010-2019**

"BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the NTA Governing Board hereby clarifies that the Calamity Assistance granted to farmers affected by Typhoon "Ompong" is entirely separate and distinct from the Curing Barn Assistance Project (CBAP) and not deductible from the availment of the latter assistance.

#### UNANIMOUSLY APPROVED......"

## C. NTA TOBACCO FARMERS TRAINING CENTER BUILDING AT SAN JUAN, ILOCOS SUR

Upon the unanimous agreement among the members of the board, the following resolution was adopted, to wit:

#### **RESOLUTION NO. 1011-2019**

"BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the NTA Governing Board hereby authorizes the Vice-Chairman/Administrator to formally notify the Municipality of San Juan, Ilocos Sur, or any government instrumentality, that it is the policy of the Agency that for NTA Branch Offices without existing parcels of land, where the NTA Tobacco Farmers Training Center Buildings shall be constructed, only government-owned lands shall be accepted as sites for the construction of the said NTA training buildings; Provided, that there should be a Usufruct Agreement between the NTA and the concerned government instrumentality for at least twenty-five (25) years and renewable for another twenty-five (5) years.

UNANIMOUSLY APPROVED......"



### D. MONTHLY TRAVELLING EXPENSES FOR EXTENSION WORKERS

It was learned yesterday from Ms. De Peralta that it is now the primary concern of Extension Workers of NTA-Candon Branch Office that the Php1,000.00, per month, TEV for TPRO I and Agriculturist I is not enough due to the effect of the TRAIN Law. However, she said that only those receiving Php1,000.00 monthly TEV were increased to Php1,200.00, per month, but not with the other Extension Workers receiving higher TEVs. She requested from the board if the TEV can be further increased by fifty percent (50%).

Dir. Casela moved to increase the TEV by Php200.00, per month, across all positions. Dir. Mendiola seconded the motion. The board then adopted the following resolution, to wit:

#### **RESOLUTION NO. 1012-2019**

"BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the NTA Governing Board hereby approves the increase of Monthly Travelling Expense Voucher (TEV) for Extension Workers (EW) by Php200.00, per month, across all positions, except those personnel who are receiving Representation Allowance and Travelling Allowance (RATA), effective 01 January 2019.

## E. REQUEST FOR THE HIRING OF TWO (2) JOB ORDER ACCOUNTING PERSONNEL FOR THE NTA-ILOCOS NORTE BRANCH OFFICE

Ms. Luzviminda U. Padayao, Officer-in-Charge of the NTA-Ilocos Norte Branch Office, requested during yesterday's committee meeting for the hiring of two (2) job order accounting personnel to assist the accountant in her work due to the number of personnel being serviced which include the NTA-Branch Office, Farm Services and Technology Department (FTSD) and Industrial Research Department (IRD). However, Ms. Laudencia reminded that the increase of MOOE will reduce the amount to be granted for the CNA Incentive. She then warned the branch offices that CNA Incentives shall be apportioned per department or branch office based on their MOOE utilization.

On motion of Dir. Casela duly seconded by Dir. Mendiola, the board adopted the following resolution, to wit:

#### **RESOLUTION NO. 1013-2019**

"BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the NTA Governing Board hereby approves the hiring of two (2) Job Order Accounting Personnel for the NTA-llocos Norte Branch Office to cater the personnel of the Branch Office, Farm Services and Technology Department (FTSD) and the Product Development Division-Industrial Research Department (PPD-IRD).

## F. AMENDMENTS TO THE 2018 REVISED TRADING RULES AND REGULATIONS

Dir. Salanga called the attention of the Manager, Regulation Department, with respect to the requirement of submission of Performance Bond that it shall be required only for those Buying Stations without Marketing Agreement. Further, he said that the deadline for filing of application for licenses/permits to buy/purchase/redry tobacco should be moved to January 31 to give ample time for the applicants to submit the supporting documents, such as but not limited to Business Permits, Performance Bond, etc..

On motion of Dir. Salanga, duly seconded by Dir. Casela, the board adopted the following resolution, to wit:

#### **RESOLUTION NO. 1014-2019**

"BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the NTA Governing Board hereby approves the amendment of the 2018 Revised Rules and Regulations Governing the Trading of Locally Grown Leaf Tobacco (2018 Revised TRR) that only those Buying Statins without marketing Agreement shall be required to submit Performance Bond in their application for new/renewal of licenses/permits to buy/purchase tobacco.

**RESOLVED**, **FURTHER**, that the deadlines for the filing of applications for new/renewal of licenses/permits to buy/purchase/redry leaf tobacco are hereby moved to January 31 of each year.

RESOLVED, FINALLY, that the Vice-Chairman/Administrator is hereby authorized to issue the corresponding Memorandum Circular on the aforesaid amendments to the 2018 Revised TRR and to cause the filling of the said MC with the University of the Philippines - Office of the National Administrative Register (UP-ONAR).
