C. NTA AGENCY PLAN AND BUDGET (APB) FOR FISCAL YEAR (FY) 2020

On motion of Dir. Salanga, duly seconded by Dir. Casela, the NTA Governing Board adopted the following resolution, to wit:

D. LETTER-REQUEST OF OCCUPANTS OF THE NTA PROPERTY AT PACO, MANILA, AND WHO ARE RESPONDENTS IN THE CIVIL CASES FILED BY THE NTA FOR RECOVERY OF POSSESSION

Atty. Roberto M. Sison informed the NTA Governing Board on the letterrequest of respondents of the civil cases filed by NTA against some of the occupants of the NTA property located at Paco, Manila.

Upon motion of Dir. Salanga, duly seconded by Dir. Victorio and Dir. Martinez, the board adopted the following resolution, to wit:

"BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the NTA Governing Board hereby denies the request of the Respondents in the Civil Cases for Recovery of Possession filed by the NTA pending before the Regional Trial Court of Manila, Branch 39.

RESOLVED, **FURTHER**, that the NTA Legal Counsel is hereby directed to continue with the proceedings of the said cases in the event that the Respondents should fail to agree with the deadline set for the full payment of the lot/s awarded to them on or before March 31, 2020.

V. OTHER MATTERS

A. IFOIGAP-RICE PRODUCTION ASSISTANCE WET SEASON 2019

Ms. Imelda N. Riñen reported that the NTA will be providing production assistance for IFOIGAP-Rice WS 2019 covering 5,184 farmer-



cooperators with a total of 2,592 hectares at P20,000.00 per hectare, with a total budget allocation of Php51,840,000.00. She said that the total amount may not be utilized if there would be more rains that would come after the deadline set on May 15, 2019. She said that based on the area and number of farmer-cooperators (FCs), each Extension Worker will supervise 18 hectares and 36 FCs. She informed the NTA Governing Board that the coverage includes Cagayan, Isabela and Tarlac Provinces.

Dir. Casela recommended that the workload of each EW should be correspondingly increased. He said he don't know the reason why the workload is decreasing. Ms. Riñen replied that the area to be covered for CY 2019 increased by 100 hectares compared to last year's IFOIGAP-Rice coverage, however, she said that the Technical Committee on Performance Evaluation agreed to set a target of 1 EW:30 ha.:60 FCs.

Dir. Victorio suggested that NTA Management should train staff per branch office as Rice Experts. He also recommended to provide seeds to farmers which have "blue tags". He also suggested to centralize the procurement of palay seeds so that NTA will be assured that only seeds with blue tags will be used by the farmer-cooperators.

Dir. Quintal added that the rice experts should be present during the distribution of seeds to conduct simple orientation on how to properly manage and culture their rice produce.

Ms. Riñen requested from Dir. Victorio if the NTA Rice Production Coordinators can visit his farm to learn. Dir. Victorio instead suggested to Ms. Riñen to visit the model farms at PhilRice Muñoz, Nueva Ecija, because those farms also integrate other farming activities such as poultry and hog raising.

Upon motion Dir. Casela, duly seconded by Dir. Victorio and Dir. Quintal, the board adopted the following resolution, to wit:

RESOLUTION NO. 1060-2019

"BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the NTA Governing Board hereby sets the deadline for the submission by the NTA Branch Offices on the number of farmer-cooperators for the IFOIGAP-Rice CY 2019 Wet Season on or before 06 May 2019.

RESOLVED, **FURTHER**, that only palay seeds with "Blue Tag" shall be used for the project and the procurement of which shall be centralized to be assured of the source/s of the seeds.

RESOLVED, STILL FURTHER, that the Farm Services and Technology Department (FTSD) is hereby directed to organize the retraining of NTA Staff as Rice Experts to be conducted by Accredited Trainer/s from the Philippine Rice Research Institute (PhilRice).



RESOLVED, **FINALLY**, that the NTA Management is hereby authorized to conduct the public bidding for the procurement of farm inputs for the IFOIGAP-Rice CY 2019 Wet Season.

UNANIMOUSLY APPROVED......"

B. DEMOLITION OF OLD NTA CENTRAL OFFICE BUILDING

Dr. Lopez reported that she already coordinated with the Bureau of Internal Revenue (BIR) with respect to the procedure they adopted for the demolition of their old building at Intramuros, Manila. She said she was informed by the BIR officials that they even realized income of about Php600,000.00 from the said demolition. She recommended to the NTA Governing Board for the immediate demolition of the old NTA Building.

Dir. Victorio suggested to demolish the building as soon as possible due to series of earthquakes for the past days. He said it is no longer safe to stay and all personnel staying thereat should immediately vacate the old building.

Dir. Casela also suggested to remove all air conditioning units from the old building and distribute the same to the different NTA Branch Offices.

Dir. Salanga inquired on the negotiation for the engagement of services of the Department of Public Works and Highways (DPWH). Dr. Lopez said that the DPWH has already given the go signal for NTA to proceed with the demolition and can now work out with the application for demolition permit with the Quezon City Building Official.

C. CAPABILITY ENHANCEMENT FOR THE INDUSTRIAL RESEARCH DEPARTMENT

Dr. Bonoan reported that he already coordinated with the manufacturing sector on the latest modalities of laboratory equipment for cigarette testing. Ms. Benosa added that the DBM allowed the inclusion of the unutilized budget for Capability Enhancement of previous years and it was already included in the APB for FY 2020.

The NTA Governing Board likewise recommended the inclusion of budget for the establishment of the Tobacco Grading Institute.

D. IDENTIFICATION OF FOCAL PERSON/S PER PROGRAM/PROJECT

Dir. Casela moved for NTA Management to identify focal person for each project to be able to assist Dir. Drapete on financial and technical budgetary concerns. Dir. Salanga seconded the motion. Thereafter, the board adopted the following resolution, to wit:

RESOLUTION NO. 1061-2019

"BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the NTA Governing Board hereby directs the NTA Management to designate focal person/s for the following NTA Programs and Projects, to wit:

- Total Contract Growing System of all tobacco farmers, whether NTA-assisted or Buyer-Firm Assisted, with 100% subsidy on farm inputs;
- Increased coverage of IFOIGAP-Rice Production with 20% subsidy;
- Curing Barn Assistance Project with 20% subsidy, including standardization/improvement of curing barn design;
- d. Irrigation Facility Assistance Projects, such as, water impounding, water pumps;
- e. Farm Mechanization to deter farm labor inadequacy and reduction of cost of production;
- f. Fuelwood Sustainability through Reforestation Projects, Revival of the KPP Project, Synchronized Tree Planting;
- g. Scholarship Program for Tobacco Farmer Dependents;
- h. Livelihood Trainings for Tobacco Farmers;
- i. Establishment of the Tobacco Grading Institute;
- j. Farmers Organizational Development Program;
- k. Seedling Production Project;
- Research Expansion on the Alternative Uses of Tobacco;
- m. Standardization of Contents of Cigarettes, such as Nicotine, Tar and Carbon Monoxide;
- n. Rationalization of the Organizational Staffing Pattern to cope-up with the increasing mandates of the NTA;
- Career Development and Training Opportunities for All NTA Officials and Staff; and
- Infrastructure Projects, such as construction of new NTA Central Office Building.

The assigned focal person/s for each program/project shall be responsible for the determination of budgetary needs for the implementation of all components under each program/project.
