# RE-INVITATION TO BID SUPPLY AND DELIVERY OF 445 HEADS OF BRAHMAN HEIFER CATTLE BREED FOR USE IN IFOIGAP – BEEF/CATTLE PRODUCTION ASSISTANCE PROJECT

(PB 2017-11A)

- 1. The NATIONAL TOBACCO ADMINISTRATION (NTA), through the 2017 Corporate Operating Budget intends to apply the sum of PhP19,777,500.00, being the Approved Budget for the Contract (ABC), to payments under the contract for the project: "Supply and Delivery of 445 Heads of Brahman Heifer Breed Cattle for Use in IFOIGAP—Beef/Cattle Production Assistance Project". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The NTA now invites bids for the supply and delivery of 445 Heads of Brahman Heifer Cattle Breed. Delivery of the Goods is required for a period of sixty (60) days, from receipt of the Notice to Proceed. Bidders should have completed, within a period of five (5) years, from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

### The Technical Specifications are as follows:

- > Breed Brahman Heifer;
- High Grade Commercial;
- Not less than 220 Kilos per Cattle at time of delivery;
- > 20-24 months old;
- Dewormed and vaccinated Hemosep at least two (2) weeks prior to delivery and certified by a licensed government veterinarian;
- > Tested free from Brucellosis, as certified by the Bureau of Animal Industry (BAI);
- Must not possess any physical defects / conditions or undesirable characteristics;
- With health certificate;
- Sourced from BAI accredited Cattle farm; and
- Winning Bidder should have an available 445 heads of cattle at the time of Post Qualification.
- Delivery period shall be within 60 days, from receipt of the Notice to Proceed.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

- (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
- (ii) Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.
- 4. Interested bidders may obtain further information from NTA and inspect the Bidding Documents at the address given below during 8:00 am to 5:00 pm.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders beginning on November 29, 2017 to December 19, 2017, from the address below; and upon payment of the bidding fees for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of PhP25,000.00.
- Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- Bid opening shall be on **December 19**, **2017**, **at 10:00 a.m.**, at 3<sup>rd</sup> Floor, Training Room, NTA Building, cor. Scout Reyes Street and Panay Avenue, Quezon City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.



- 8. The NTA reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
