#### **CONTRACT AGREEMENT**

THIS AGREEMENT, made this 17th day of August, 2012 between NATIONAL TOBACCO ADMINISTRATION, Cors. Scout Reyes Street and Panay Avenue, Quezon City, hereinafter called the "Entity", and AVM BERNARDO ENGINEERING, No. 604 T.
