CONTRACT AGREEMENT

THIS AGREEMENT, made this November 23, 2017, between NATIONAL TOBACCO ADMINISTRATION, Cors. Scout Reyes Street and Panay Avenue, Quezon City, hereinafter called the "Entity", and L.F. CABREROS AGRI & FARM SUPPLY, with office address at San Pedro, Narvacan, Ilocos Sur, hereinafter called the "Supplier".

WHEREAS, the Supplier was a lone eligible bidder, who submitted its bid proposal for the Project: "Supply & Delivery of 380 Heads of F1 Type Hogs for Use in the AgriPinoy Project Training School", with Contract Identification No. NP 2017-10, hereinafter called the "Goods", and was declared as the Single Calculated and Responsive Bid (SCRB), in the amount of Five Million, Four Hundred Thirty-Four Thousand Pesos (PhP5,434,000.00), offered by the Supplier for the delivery of such Goods, for a period of 60 calendar days, and the remedying of any defects therein, effective five (5) calendar days upon receipt of the Notice to Proceed.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectfully assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - a) General and Special Conditions of Contract;
 - b) Specifications;
 - c) Invitation to Bid;
 - d) Instructions to Bidders:
 - e) Bid Data Sheet;
 - f) Addenda and/or Supplemental/Bid Bulletins, if any;
 - g) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
 - h) Eligibility requirements, documents and/or statements;
 - i) Performance Security:
 - j) Notice of Award of Contract and the Bidder's conforme thereto; and
 - k) Other contract documents that may be required by existing laws and/or the Entity.
- In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to deliver the Goods/Services and remedy any defects therein in conformity with the implementation of this Contract in all respects.
- 4. The Entity hereby covenants to pay the Supplier in consideration of the delivery and installation of the Goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of this Contract at all times and in the manner prescribed by this Contract, and all pertinent doctorents attached herewith.
