Invitation to Bid Supply and delivery of fertilizer requirements for ifoigap rice – wet season, 2019 FOR REGIONS I, II and CAR (PB 2019-01)

- 1. The NATIONAL TOBACCO ADMINISTRATION (NTA), through the 2019 Corporate Operating Budget intends to apply the sum of PhP14,319,622.00, being the Approved Budget for the Contract (ABC) to payments under the contract for the project: "Supply and Delivery of Fertilizer Requirements for IFOIGAP Rice –Wet Season, 2019", broken into four (4) lots, as follows: Lot 1 (Ilocos Norte and Vigan): PhP3,548,230.00; Lot 2 (Abra and Candon): PhP4,186,988.00; Lot 3 (La Union and Pangasinan) PhP3,935,581.00; and Lot 4 (Isabela and Cagayan): PhP2,648,823.00. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The NTA now invites bids for the supply and delivery of fertilizer requirements for IFOIGAP Rice-Wet Season, 2019. Delivery of the Goods is required for a period of fifteen (15) days. Bidders should have completed, within a period of five (5) years, from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
 - (ii) Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.
- 4. Interested bidders may obtain further information from NTA and inspect the Bidding Documents at the address given below during 8:00 am to 5:00 pm.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on May 18, 2019 to June 10, 2019, from the address below; and upon payment of the bidding fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the following amount, to wit:

Lot 1 PhP5,000.00; Lot 2 PhP5,000.00;

Lot 3 PhP5,000.00; and Lot 4 PhP5,000.00

June 10, 2019. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
