In view of the two (2) failed biddings (PB 2016-01 and PB 2017-02), and the failure of the Negotiated Procurement, which was set on 07 August 2017, the NTA - Bids and Awards Committee (BAC) invites service providers to participate in the negotiated procurement for the Project: Security Services for the Offices of the (NTA), at the National Capital Region (NCR), Regions I, II, CAR and IV-A, in accordance with the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184.   - b) PhilGeps Registration Certificate
- 3. For new prospective bidders, Eligibility and Technical components of their bids shall be submitted, in conformity with the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, for evaluation.
- 4. An initial meeting with interested service providers will be conducted on 31 August 2017, and the submission of the best and final offer will be on 05 September 2017, both of which shall be conducted at 10:00 a.m., 3<sup>rd</sup> Floor Training Room, NTA Building, Scout Reyes Street corner Panay Avenue, Quezon City.
- 4. Interested bidders may obtain further information from the NTA-BAC, during working days from 8:00 a.m. to 5:00 p.m., upon payment of a non-refundable negotiated procurement/ bidding fee, as follows:

Lot 1 – PhP5,00000; Lot 3 – PhP5,000.00; Lot 4 – PhP5,000.00; and, Lot 5 – PhP5,000.00
