Dir. Salanga reported that the Members of the Board discussed the matter during yesterday's committee meeting wherein the Officers of the association were present. It was agreed that the NTA will grant an extension of two (2) years for the lot awardees with the condition that those who will not be able to pay in full the cost of the lot awarded after the extension, all their payments shall be forfeited and shall return the possession of the lot they respectively occupy.

H. REQUEST FOR AUTHORITY FOR THE DIFFERENT NTA BRANCH OFFICES TO USE THEIR FERTILIZERS AND PESTICIDES INVENTORIES UNDER THE TCGS CY 2017-2018 TO IFOIGAP-RICE PROJECT FOR CY 2018 AND/OR TCGS CY 2018-2019

Upon motion of Dir. Casela, duly seconded by Dir. Quintal, the board adopted the following resolution, to wit:

"BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the NTA Governing Board approves the request of the different NTA Branch Offices to use their fertilizer and pesticide inventories from the CY 2017 Integrated Farming and Other Income Generating Activities Project-Rice Component (IFOIGAP-Rice) and CY 2017-2018 Tobacco Contract Growing System (TCGS) to supplement the fertilizer and pesticide requirements of CY 2018 IFOIGAP-Rice and/or CY 2018-2019 TCGS; Provided, that the respective Branch Offices shall submit to the board the list of their fertilizer and pesticides inventories.

I. APPROVAL OF THE AMENDMENT OF THE IMPLEMENTING GUIDELINES FOR THE IRRIGATION SUPPORT PROJECT THAT THE MAXIMUM LOANABLE AMOUNT SHALL NOT EXCEED PhP100,000.00. PER AVAILEE, IRRESPECTIVE OF FARM AREA



Dir. Quintal informed the Honorable Undersecretary that prices of machineries are increasing and yet prior to this time the prices of power mover engines as per 2012 implementing guidelines are less than P100,000.00 and because of the fluctuating prices of these engines, the board increased the maximum loanable amount to P100,000.00 irrespective of farm area. He then moved for the approval of the proposed amendment to the Implementing Guidelines for the Irrigation Support Project. Dir. Martinez seconded the motion. The board then adopted the following resolution, to wit:

"BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the NTA Governing Board approves the amendment of the Implementing Guidelines for the Irrigation Support Project that the maximum loanable amount shall not exceed PhP100,000.00, per availee, irrespective of farm area.

IV. OTHER MATTERS

A. FINAL AND LAST EXTENSION OF THE CONSULTANCY SERVICE CONTRACT OF MR. REX ANTONIO P. TEOXON

Upon motion of Dir. Salanga, duly seconded by Dir. Casela, the board adopted the following resolution, to wit:

"BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the NTA Governing Board approves the last and final extension of the Consultancy Service Contract of Vir. Antonio P. Tecxon for a period of one (1) month from 16 March 2018 until 15 April 2018.

B. WATER SCARCITY IN REGION I

Usec. Laviña reported that she visited some agricultural areas in Region I and she was saddened by the situation of rice and vegetable farmers due to lack of irrigation. She narrated that she was able to actually see standing tobacco crops during her trip. She said that the National Irrigation Administration (NIA) will now be under the Department of Agriculture. However, she tearned that some existing NIA irrigation system has no water due to extreme evaporation or soil absorption. She then recommended to the NTA to study how to improve the existing irrigation structures in order to answer the needs of the farmers especially those planting garlic.

Dir. Casela replied that the soil type in Ilocos Region is arid, the reason why the NTA ventured in the construction of Small Water Impounding Project (SWIP). He further reported that the NTA has an on-going negotiations with the National Irrigation Administration (NIA) for the construction of additional irrigation system. He also said that Secretary Piñol endorsed the use of Solar Powered Irrigation System as part of the NTA irrigation project.

C. DISPLACED TOBACCO FARMERS AT SAN JOSE CITY, OCCIDENTAL MINDORO

Mr. Dela Cruz requested from the NTA the list of tobacco farmers of Occidental Mindoro so that the DA will assist them in the production of other high value crops. He also requested the contact number of the NTA employee assigned in the area. Atty. Ambros committed to send the list of tobacco farmers.

D. AGRICULTURE AND FISHERIES MANAGEMENT (AFM) PLANNING SESSION

Mr. Dela Cruz also reported that he has attended the planning session of the DA AFM. He said that the NTA is represented by Mr. Manuel Ramiscal. He said that one of the major concerns of the group is about climate change which is encouraged to be included in the mainstream of all DA programs and projects.

Dir. Casela said that the NTA is implementing the Kakahuyang Pangkalikasan at Pangkabuhayan (KPP) Project and the yearly Synchronized Tree Planting Project. He said that the objectives of the projects are to provide the farmers sufficient fuelwood for their curing and also to maintain the ecological integrity. He also informed the Honorable Undersecretary that the NTA research group has designed a special furnace (Anawang) which effectively reduced fuelwood consumption by 20% with the use of alternative biomass such as sweepings, coconut shells and husks and rice hull.

Dir. Quintal also mentioned that the NTA has planned to procure weather forecasting system which will be able to predict weather conditions in just a matter of time and this will help the farmers in protecting their crops for any eventuality. He said that the estimated cost of the system is P400,000.00, per unit.

Usec. Laviña encouraged the NTA that in the formulation of its roadmap, the tobacco farmers should be consulted and to consider finding solutions to problems for each geographical areas.

E. PROCUREMENT OF WEATHER FORECASTING SYSTEM

On motion of Dir. Quintal, duly seconded by Dir. Mendiola, the board adopted the following resolution, to wit:

RESOLUTION NO. 824-2018

"BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the NTA Governing Board approves the procurement of nine (9) units of Weather Forecasting System through public bidding, the same

to be implemented for CY 2018 and to be included in the Supplemental Budget of the NTA for FY 2018.
