C. DEVELOPMENTS ON THE FINAL EVALUATION OF THE KAKAHUYANG PANGKABUHAYAN AT PANGKALIKASAN (KPP) PROJECT

Dir. Caseia stated that during yesterday's meeting, Dr. Segundino Foronda presented his final assessment on the KPP Project. It was disclosed that there is an urgent need for the hiring of consultant to review and revise the implementing guidelines of the KPP project. He then instructed the NTA Bids and Awards Committee (NTA-BAC) to coordinate with the Technical Working Group (TWG) to formulate the terms of reference for the hiring of consultant and to determine whether the consultancy services shall be procured through public bidding or negotiation, whichever is appropriate.

On motion of Dir. Casela, duly seconded by Dir. Quintal, the board adopted the following resolution, to wit:

RESOLUTION NO. 839-2018

"BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the NTA Governing Board hereby directs the NTA Bids and Awards Committed (BAC) to coordinate with the Technical Working Group (TWG) in the formulation of the terms of reference for the hiring of consultancy services for the review and revision of the Implementing Guidelines of the Kakahuyang Pangkalikasan at Pangkabuhayan (KPP) Project.

RESOLVED, **FURTHER**, that the NTA BAC is hereby authorized to conduct the procurement of the said consultancy services either through public bidding or negotiation.

D. COMMENTS OF THE INTERNAL AUDIT SERVICE (IAS) ON THE CONDONATION OF INTERESTS AND PENALTIES FOR PAST DUE ACCOUNTS OF FARMER-COOPERATORS

On motion of Dir. Salanga, duly seconded by Dir. Mendiola, the board adopted the following resolution, to wit:

RESOLUTION NO. 840-2018

"BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the NTA Governing Board takes note of the comments of the Internal Audit Service and revokes Board Resolution No. 787-2018 condoning the interests and penalties on farmer-



cooperators' past due accounts for being violative of pertinent Commission on Audit rules and regulations.

RESOLVED, **FURTHER**, that in lieu of condonation, the farmer-cooperators are given the option to avail the restructuring of their past due accounts without interest based on the previously approved terms of repayment.

RESOLVED, **FINALLY**, that the Acting Legal Counsel is hereby instructed to revise the pro-forma demand letter based on the above developments.

IV. OTHER MATTERS

A. CONDITION FOR ENTITLEMENT OF SUBSIDY UNDER THE IFOIGAP-TCGS CY 2017-2018 AND PROCEDURE IN THE REMITTANCE AND RECEIPT OF SUBSIDY

Upon motion of Dir. Salanga, duly seconded by Dir. Casela, the board adopted the following resolution, to wit:

RESOLUTION NO. 841-2018

"BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the NTA Governing Board imposes as a condition that the farmer-cooperators under the IFOIGAP-TCGS CY 2017-2018 should have paid 100% of their production assistance before they can qualify for the 20% subsidy on farm inputs.

RESOLVED, FURTHER, that all collections under the IFOIGAP-TCGS CY 2017-2018 should first be remitted to the NTA Central Office for the determination/identification of farmer-cooperators qualified to receive the subject subsidy, which will then be fund-transferred by the NTA-Finance Department to the respective NTA Branch Offices for distribution.

UNANIMOUSLY APPROVED......"
