The Presiding Officer presented the Minutes of the Eighty-Seventh (87th) Special Meeting of the NTA Governing Board held on 24 July 2018 at the Board Room, 2/F NTA Building, Scout Reves Street corner Panay Avenue, Quezon City, for the consideration and approval of the Members.

Dir. Martinez moved for the approval of the minutes. Dir. Casela seconded the motion with suggestions for amendment of Item B on Other Matters. The board then adopted the following resolution, to wit:

APPROVAL OF THE MULTI-SECTORAL IMPLEMENTATION OF C. IFOIGAP-TCGS PROJECT WITH THE LOCAL GOVERNMENT UNITS OF ILOCOS NORTE

Dir. Casela explained that the proposed project will be a joint undertaking of the NTA, the LGUs, Tobacco Buyer Firms and the Provincial Government of Ilocos Norte (PGIN). He said that under the project, the NTA and Buyer Firms shall provide technical assistance, production assistance (cash portion), marketing assistance and proper documentation of tobacco production. For the LGUs, he said that the concerned Municipalities shall provide production assistance (farm inputs), while the NTA and BF shall provide technical assistance and the cash portion and the PGIN shall provide production assistance in the form of farm implements/machineries subject to certain conditions.

He further explained that the objectives of the project are to: a) increase the production of tobacco both quantitatively and qualitatively, as well as, increase cost-effectiveness; b) promote market-oriented approach of tobacco production; and, c) generate adequate information on tobacco production technology, postharvest and marketing, with the end in view of providing the tobacco farmers with high quality yield and high income/return of investment and contribute to the increase of excise taxes on tobacco.

He also said that the undertaking will cover the production of Virginia, Burley and Native types and sub-types with an initial target of 2,600 hectares with about 5,200 farmer-cooperators, with an estimated production assistance of P137,992,600.00, of which NTA's exposure shall be P48,642,950.00.

The criteria of selection shall follow the qualifications under the Implementing Guidelines of the NTA-TCGS, however, he said that priority shall be given to FCs who have planted tobacco for CY 2017-2018 and returning tobacco farmers who are credit worthy, as well as, those that are not financed by the NTA or buyer firms and whose farm areas have enough water supply and with existing curing barns. He also said that the undertaking will be covered by a Memorandum of Agreement and a Project Management Team shall be created to supervise the proper implementation of the project. However, he emphasized that there shall be conditions before the FCs can avail of the subsidy, such as, delivery of predetermined volume of production as evidenced by Purchase Invoice Vouchers (PIVs), and if the FCs fail to deliver 100% of their estimated production, they shall pay in full all the production assistance that were provided by the LGUs and PGIN. Production assistance provided by the NTA and BFs shall be subject to administrative fee of 2% per annum and one-time service charge of 1%.

Dir. Casela then moved for the approval of the matter. Dir. Salanga seconded the motion. The board adopted the following resolution, to wit:

E. CONSIDERATION OF THE REQUEST OF THE NTA-PANGASINAN BRANCH OFFICE FOR THE PROVISION OF ADDITIONAL CASH ASSISTANCE TO TOBACCO-RICE FARMER-COOPERATORS AFFECTED BY TYPHOONS AND MONSOON RAINS

Ms. Laudencia informed the Members of the Board that the FTSD reviewed the submission of the branch office. Ms. Riñen confirmed that the computation of the branch office includes labor costs which the NTA does not provide under the implementing guidelines for the IFOIGAP-Rice Production Project. Ms. Riñen recommended to remove the labor costs from the request with the final amount of P688,423.04 as the recommended total budgetary requirements for the affected FCs of Panagsinan.

Dir. Casela asked if the assistance will be in the form of a grant or if it is recoverable. Dir. Salanga said that the NTA has available funds under the Risk Management Program, he then moved the approval of the amount of P688,423.04 as calamity assistance and shall not be recoverable.

Dir. Mendiola seconded the motion and the board adopted the following resolution, to wit:

F. APPROVAL OF THE IMPLEMENTING GUIDELINES FOR THE IMPROVED TOBACCO SEEDLING PRODUCTION PROJECT

Ms. Rinen presented to the board the draft of the Implementing Guidelines for the Improved Tobacco Seedlings Production Project. She explained that the project will entail a total budget of P640,250.00 to be distributed to the 5 Virginia Producing Branch Offices (Batac, Vigan, Candon, La Union and Abra). She said that each Branch Office shall establish 4 separate seedling production sites with a total capacity of 240,000 seedlings. She said that the estimated cost per seedlings is P0.54.

Dir. Salanga inquired why there was an increase in the production cost of seedlings as compared to yesterday's presentation during the Committee Meeting. Ms. Riñen replied that the increase was brought about by the inclusion of machinery which was not considered in the first costing presented yesterday.

Dir. Salanga moved for the approval of the implementing guidelines as revised. Dir. Casela seconded the motion. There being no further comment, the board adopted the following resolution, to wit:

G. APPROVAL OF THE IMPLEMENTING GUIDELINES FOR THE IFOIGAP-TCGS STARTING WITH CROP YEAR 2018-2019 AND FOR YEARS THEREAFTER

Ms. Riñen presented the implementing guidelines for IFOIGAP-TCGS starting with CY 201-2019 and for succeeding crop years thereafter, for the consideration and approval by the NTA Governing Board.

Dir. Casela clarified on the conditions for the grant of subsidy which should include the yield, per farmer, supported by Purchase Invoice Vouchers (PIVs), quality of tobacco produce, compliance with the unified technology and full repayment of production assistance prior to the deadline set under the guidelines. He further said that production assistance to tobacco farmers in Region II shall cover farm inputs only and cash portion shall be provided only in the event that the TCGS budget for Region I is not fully utilized.

Dir. Quintal inquired on the deadline for the filing of claims for subsidy. Atty. Ambros suggested to that it should be filed not later than 30 calendar days after the official closing of trading operations for each tobacco type as provided under the Revised Rules and Regulations Governing the Trading and Redrying of Locally Grown Leaf Tobacco.

Dir. Salanga commented that the deadline for filing of claims shall be effective starting with Trading Season 2019 and onwards and shall not apply to Trading Season 2018.

On motion of Dir. Salanga, duly seconded by Dir. Quintal, the board adopted the following resolution, to wit:

I. PROJECT PROPOSAL ON "SPECIAL TOBACCO PRODUCTION PROJECT IN SOUTHERN MINDANAO"

Dir. Martinez recalled that the representatives of the Asian Pyrochem Technologies Inc. (APTI) attended the committee meeting yesterday and presented the concept of the project. He said that the APTI representatives explained that they will consolidate the parties to the project to be participated in by national government agencies, farmers' cooperatives and local government units and shall engage the NTA for the provision of the funding requirement for the initial 20-hectare area, while the postharvest and demonstration farms shall be financed by a government financial institution, while APTI will participate on the production and marketing side.

Dir. Quintal recalled that when he visited the area in Mindanao to evaluate the sites of the demo farms in order to determine whether tobacco can be grown, he thought that APTI already had the technology and shall only undergo verification trial by the NTA, if effective and it was his understanding that AI Amanah Bank will be the one to finance the 40-hectare production area, while NTA will finance the 2-hectare demo farms.

Dir. Martinez further reported that Engr. Atar of APTI explained that the TESDA will facilitate and finance the trainings. He said that after hearing the position of NTA, Engr. Atar requested the NTA if it can also include financing the establishment of curing barns commensurate to the 2-hectare demo farms.

Dir. Salanga emphasized that NTA can finance only the 2-hectare demo farms. Dir. Martinez committed to coordinate with Atty. Roberto Sison for the preparation of a Memorandum of Agreement reiterating the appeal of Mr. Leaño if the NTA can increase the demo farms to 5 hectares but the board agreed to allow only 4 hectares as demo farms.

Dir. Casela emphasized that funds to be utilized for the demon farms shall not be recoverable, however, he said that once the TCGS project is established and the NTA will provide production assistance, it shall become recoverable.

On motion of Dir. Martinez and without further comment from the other members, the board adopted the following resolution, to wit:

J. CREATION OF A TECHNICAL WORKING GROUP TO REVIEW/REVISE/AMEND THE IMPLEMENTING GUIDELINES OF THE RENEWABLE FUELWOOD ENERGY DEVELOPMENT PROJECT AND RESTORATION OF ECOLOGICAL INTEGRITY PROJECT (KAKAHUYANG PANGKALIKASAN AT PANGKABUHAYAN (KPP) PROJECT)

Atty. Verzosa reported that he already submitted to the Honorable Administrator the draft of the Special Order creating the KPP National Project Management Team (NPMT) and Provincial Branch Project Management Team (PBPMT). He said that the NPMT shall be responsible in supervising the implementation, monitoring and evaluation of the project, while the PBPMT shall be responsible for the project implementation in their respective area of coverage.

Atty. Verzosa said that Mr. Hermogenes Galvez will be tasked to work on the details of the project. Mr. Galvez explained the operation of the Tobacco Dust Project. Dir. Salanga suggested that Mr. Galvez should find a way to cut the cost of production of tobacco dust and to submit a written report to the board. The board then adopted the following resolution, to wit:

subject to the completion of the rehabilitation of the laboratories at IRD-Batac, llocos Norte. He then reported that the rehabilitation works were already completed, hence, he requested the board for the approval of the matter. He informed the board that each project for tobacco hand-made paper, tobacco extraction laboratory and pulp production have already their own laboratory room which can be a good venue for demonstration to interested parties. He further said that with the new equipment to be purchased, the hand-made paper may now be converted into specialty paper for certificates and calling cards.

Dir. Casela asked Dr. Bonoan if NTA has plans to commercialize the hand-made paper. Dr. Bonoan replied that while the technology is ready for transfer, it will entail huge investment, there is a need to explore into partnership with third party who are willing to venture on the projects or as backyard livelihood undertaking with interested cooperatives through production assistance from the NTA. However, Dr. Bonoan said that the NTA is still enhancing the technology to become competitive such as mixing it with abaca fiber.

Dri. Salanga moved for the approval of the request. Dir. Casela seconded the motion. There being no further comment, the board adopted the following resolution, to wit:
