IV. OTHER MATTERS

A. APPROVAL OF THE AWARD OF CONTRACT FOR THE PROJECT: "LEASE OF OFFICE SPACE BY THE NATIONAL TOBACCO ADMINISTRATION (NTA) FOR USE AS ITS CENTRAL OFFICE" IN FAVOR OF BEN-LOR REALTY TRADING AND PUBLISHING CORPORATION WITH THE LOWEST QUOTATION OF PHP758.93, PER SQUARE METERS

Dir. Mendiola asked on the date of effectivity of the lease contract. Atty. Ambros replied that he is not sure of the exact date of effectivity, however, he said that as per bidding procedure, once the contract is signed, the winning bidder shall be given seven (7) days to deliver the premises after the receipt of Notice to Proceed. Dir. Mendiola also commented that there are only 10 parking slots available for NTA which is not enough for officials and staff. Atty. Ambros reported that the NTA premises will still be used by the service vehicles and the 10 available parking slots shall be utilized by the officials and employees.

Still on related matter, Dir. Mendiola questioned the timeliness of leasing the subject office space when the NTA building is not yet due for demolition. Atty. Ambros replied that the transfer of offices was due to the report that the building is not structurally sound and the Manager of the Administrative Department is very much concerned on the safety of all officials and employees.

Mr. Dela Cruz inquired on the duration of the lease contract. Atty. Ambros replied that it is on a year to year basis, renewable every year.

Dir. Casela inquired on the status on the development on the proposed construction of new building. Atty. Ambros reported that the NTA Management has already discussed the matter with consultant/structural engineer has already recommended for the construction of new building instead of retrofitting the building. Atty. Ambros further reported that the consultant will prepare his costings to show that the cost of retrofitting is more than 60% of the cost for the construction of a new one. He said that the recommendation and costings will be submitted to the DPWH for review before submission to the DBM for funding. Dir. Casela asked who will approve the recommendation of the consultant. Atty. Ambros responded that the Honorable Administrator will submit his final recommendation for approval by the board.

Without further comment from the members of the board and on motion of Dir. Mendiola, duly seconded by Dir. Trongco, the board adopted the following resolution, to wit:

RESOLUTION NO. 928-2018

"BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the NTA Governing Board approves the award of contract for the project: "Lease of Office Space by the National Tobacco Administration (NTA) For Use As Its Central Office" in favor of Ben-Lor Realty and Publishing Corporation with the lease rate in amount the of Php758.93, per square meter, for the first year of lease, for a total of 1,550 square meters, renewable every year, upon mutual consent by the NTA and Ben-Lor.

RESOLVED, FURTHER, that the Vice-Chairman/Administrator is hereby authorized to issue the Notice of Award to the winning bidder and execute the corresponding Contract/Agreement for and in behalf of the NTA, as well as issue the Notice to Proceed.

B. APPROVAL OF THE AWARD OF CONTRACT FOR THE PROJECT: "SUPPLY AND DELIVERY OF PLC SIEMENS CONTROLLER FOR SMOKING MACHINE CERULEAN SM450 AND SMOKING HEAD 70ML ASSEMBLY FOR SM450 (2 PUFF ENGINE)" IN FAVOR OF WCD INTERNATIONAL CORPORATION WITH THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) IN THE AMOUNT OF PHP938,352.00

Dir. Casela asked Dr. Bonoan because there is a pending request for the board to approve the award of contract for the purchase of smoking machine. He asked if the subject purchase is different from the one already purchased years ago. Dr. Bonoan said that this is different because the new smoking machine will be used to test IQOS and similar tobacco products.

Dir. Mendiola asked if the unit is new or just a duplication of the existing unit and what is the purpose of purchasing a new one. Ms. Lozano clarified that the subject of the purchase is actually the replacement of the computer unit of the existing smoking machine which was found defective.

Dir. Casela requested for the amendment of the BAC Resolution to clarify that the subject award is not a smoking machine but a replacement of the computer unit which is only a part of the existing smoking machine.

Upon unanimous decision, the board adopted the following resolution, to wit:

RESOLUTION NO. 929-2018

"BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the NTA Governing Board approves the award of contract for the project: "Supply and Delivery of PLC Siemens Controller for Smoking Machine Cerulean SM450 and Smoking Head 70ml Assembly for SM450 (2 Puff Engine)" in favor of WCD International Trading Corporation with the single and lowest quotation in amount the of Php938,352.00.

RESOLVED, **FURTHER**, that the BAC Resolution be amended to clarify that the subject purchase is not for the whole Smoking Machine itself but only the computer part which was found defective.

RESOLVED, FINALLY, that the Vice-Chairman/Administrator is hereby authorized to issue the Notice of Award to the winning bidder and execute the corresponding Contract/Agreement for and in behalf of the NTA, as well as issue the Notice to Proceed.

UNANIMOUSLY APPROVED......"

Dir. Casela also asked Ms. Lozano what benefit does the NTA get from the smoking machine Ms. Lozano explained that the smoking machine analyzes the tar, nicotine and carbon monoxide of cigarettes. The analysis is just an initial step in establishing standards. Ms. Lozano reported that the Philippines is behind from other European countries. She also said that tar, nicotine and carbon monoxide testing are now obsolete and the trend is more on other cigarette contents and ingredients.

Dr. Bonoan also reported that there was already a draft of proposed regulation on the limit of cigarette contents as part of the NTA's regulatory authority in the monitoring of tobacco products. He said that the results of analyses will categorize a tobacco product as high priced, medium priced and low priced. However, Dr. Bonoan said that the draft of regulation was not submitted to the board for approval. He then requested for the purchase of new Smoking Machine for IQOS and other similar tobacco products.

Upon unanimous decision, the board adopted the following resolution, to wit:

RESOLUTION NO. 930-2018

"BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the NTA Governing Board approves the request of the Industrial Research Department for the purchase of new Smoking Machine capable of testing/analyzing new tobacco products, such as IQOS and other similar products.

UNANIMOUSLY APPROVED......"
