IV. OTHER MATTERS

A. DAMAGES OF TYPHOONS

Ms. Riñen reported that there were 4,208 tobacco farmers whose curing barns were damaged by the recent typhoon. She also reported that there were 3,242 tobacco-rice farmers whose rice plantation were damaged. She said that the NTA needs the total amount of Php14.9Million for the grant of calamity assistance in the amount of Php2,000.00, per farmer.

Dir. Quintal however said that the amount of PhP2,000.00 is not enough for the farmers to recover from the damages that they sustained. Dir. Casela said the NTA is appropriating only the available funds. Dir. Quintal recalled

that Ms. Laudencia stated during yesterday's committee meeting that the NTA can realign some cash from other projects and NTA can grant more amount of calamity assistance when NTA will be able to request additional funds from the DBM.

Ms. Laudencia clarified that under the Risk Management Program, the NTA have only Php3.3Million remaining funds, and in order to raise the PhP14.9Million she suggested to realign 11.6Million from the other projects.

Without further comment from the members of the board and on motion of Dir. Salanga, duly seconded by Dir. Quintal, the board adopted the following resolution, to wit:

RESOLUTION NO. 953-2018

"BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the NTA Governing Board approves the grant of Php2,000.00, per tobacco farmer, for a total of 7,450 tobacco-rice farmers, whose curing barns and rice plantation were damaged by Typhoon Ompong, with a total budget of Php14.9Million, subject to compliance with the requirements/conditions imposed on the previous implementing guidelines for the similar grant of calamity assistance.

RESOLVED, **FURTHER**, that in addition to the remaining fund of PhP3.3Million from the Risk Management Project, the NTA Governing Board hereby approves the realignment of the amount of PhP11.6Million from other items from the Approved NTA FY 2018 COB.

B. GRANT OF CASH ASSISTANCE FOR THE NATIONAL FEDERATION OF TOBACCO FARMES' ASSOCIATION AND COOPERATIVES INC. (NAFTAC) IN PAYMENT FOR THE FEES TO THE SECURITIES AND EXCHANGE COMMISSION (SEC)

F. AMENDMENT OF THE GUIDELINES FOR THE IFOIGAP-RICE AND IFOIGAP TCGS

Upon unanimous decision, the board adopted the following resolution, to wit:

RESOLUTION NO. 958-2018

"BE IT RESOLVED, AS IT IS HEREBY RESOLVED, that the NTA Governing Board approves the amendment of the implementing guidelines for the IFOIGAP-Rice and IFOIGAP-TCGS that the 85% repayment as one of the qualifications/eligibilities shall refer to the same IFOIGAP component (Rice only or TCGS only) and shall not refer to repayment performance for the other IFOIGAP component/s.

UNANIMOUSLY APPROVED....."

G. REQUEST FOR THE RETENTION OF JOB ORDER STATUS OF TECHNICAL/RESEARCH STAFF

Ms. Riñen requested from the Honorable Members of the NTA Governing Board to exempt the Technical/Research Staff of the FTSD from the coverage of COA-CSC-DBM Joint Circular No. 1, S. of 2017dated 15 June 2017, limiting the hiring of Job Order Hirees until December 31, 2018 only. She said that research undertakings are crucial and that the termination of their services will affect all on-going research of the Agency.

Dr. Lopez informed the Honorable Members of the NTA Governing Board that there was series of consultations conducted by the DBM, CSC and COA with respect to the issuance of Joint Memorandum Circular No. 1, S. of 2017. The subject consultations were for the purpose of reconsidering and/or clarifying the first issued joint memo circular in response to numerous queries from various government agencies.

(declared moot and academic with the issuance of the Joint Memorandum Circular No. 1, Series of 2018 dated November 9, 2017 from the Department of Budget and Management, Civil Service Commission and the Commission on Audit, extending the contract of service and job order hires until December 31, 2020)

H. NTA HOUSING PROJECT AT RODRIGUEZ (MONTALBAN), RIZAL

Dr. Lopez presented to the NTA Governing Board the background of the NTA Housing Project at Rodriguez, Rizal, explaining that the amount of Tobacco Trading Augmentation Fund which was part of the Omnibus Credit Line should be deducted from the total obligation of the NTA with the PDIC. She explained that the subject amounts which were availed by



benefitted therefrom. She said that the proposal was in consideration of the effort to revive the housing project and make the housing lots affordable to employees which she projected to be at Php1,603.13 per square meter. However, she proposed that commercial lots shall be sold at Php5,000.00, while the middle portion at Php3,500.00 and the back portion at Php1,000.00.

Dir. Salanga suggested that NTA Management should negotiate with the PDIC on how much the NTA can start to pay with. He also instructed Dr. Lopez to follow up the request with the DBM.
