## NATIONAL TOBACCO ADMINISTRATION CORPORATE OPERATING BUDGET FY 2022

#### **EXECUTIVE SUMMARY**

#### MANDATE AND OBJECTIVES

The NTA is the sole government Agency vested with the power to administer and regulate the local tobacco industry. **Executive Order No. 245,** series of 1987, mandates the Agency to:

- Improve the living conditions and raise the quality of life of the tobacco farmers including those who depend upon the industry for their livelihood; and,
- 2. Promote the balanced and integrated growth and development of the tobacco industry to help make agriculture a solid basis for industrialization.

#### **POWERS**

To effectively and efficiently carry out its mandate, the Agency is vested with the specific powers to, among others:

- Promulgate and enforce rules and regulations on the production, standardization, classification, grading and trading of tobacco and tobacco products as may be necessary to attain its purposes and objectives and pursue the policy of government on tobacco; and,
- Conduct agricultural and industrial research and establish, operate and maintain experimental stations.

ADDITIONAL MANDATE: In addition, Section 33 of Republic Act No. 9211, entitled, Tobacco Regulation Act of 2003, mandates the NTA to implement the following programs and projects:

- Tobacco Growers Assistance Program to support financially the NTA registered tobacco farmers who may be displaced due to the implementation of the said RA or has voluntarily ceased planting tobacco;
- Promote Tobacco Growers Cooperatives Program to assist tobacco farmers in developing alternative farming systems, plant alternative crops and other livelihood projects;
- National Tobacco Free Public Education Program to provide scholarship for dependents of tobacco farmers in collaboration with state colleges and universities;
- 4. Research and Development Program to undertake studies concerning technologies and methods to reduce the risk of dependence on or injury from tobacco product usage and exposure and Development of Alternative Uses of tobacco and similar research programs.

#### VISION

Within the medium-term, NTA envisions:

"An improved quality of life of the tobacco farmers and other stakeholders through increased productivity and other income-generating activities."



#### MISSION

For the effective actualization of the vision, NTA is committed to:

Enhance capabilities, build synergistic relationship among sectors, and mobilize resources for the development of the tobacco industry, in accordance with national laws, policies and commitments, for the benefit of the tobacco farmers and other industry stakeholders.

## NTA CORPORATE PRIORITIES ALIGNED TO THE DA PILLARS/STRATEGIES

In pursuance of its mandates and thrusts, and in line with the Department of Agriculture's Pillars and Strategies towards "Masaganang Ani at Mataas na Kita", the NTA accords top priority to the following programs/projects/activities for CY 2022:

- I. FARM CLUSTERING(BLOCK FARMING)/ BAYANIHAN AGRI-CLUSTERS/ POST-HARVEST PROCESSING/ MARKETING SUPPORT
  - Market-Driven Quality Tobacco Production, addressing the growing demand for domestic manufacturing and export markets, primarily through the:
    - Tobacco Contract Growing System (TCGS) that will include the provision of production, technical and marketing assistance, and 40% subsidy to tobacco farmers cooperators. It targets to assist about 6,000 tobacco farmers;
      - Provision of Bio-Stimulant for Rain Damaged Tobacco as a mitigation measure for the affected crops of tobacco farmers.
    - Curing Barn Assistance Project (CBAP), involves the provision of construction and repair of about 3,000 curing barns and curing shed for the tobacco farmers of Regions 1, 2 and CAR;
    - ➤ Tobacco Farm Mechanization Program (TFMP), with the objective of assisting the block farms and in mechanizing the manual field activities and solve the lack of farm labor, about 40 farm tractors and power tillers will be distributed to qualified tobacco farmers associations/cooperatives;
  - Emergency Cash Assistance Program, as additional subsidy from the National Government, shall be provided to tobacco farmers who have been affected by the calamities such as freak rains, floods, drought, among others;
  - 3. Integrated Farming and Other Income Generating Activities Project (IFOIGAP). Funded under the agency's Corporate Funds, these include:
    - Rice Production Project as a continuing support to food security, which beneficiaries and budget have been continuously increased;
    - Chicken Layer "Egg Machine" Project, as a response to food security during the pandemic and owing to the success of the first implementation, this project will be expanded to other tobacco farmers;
    - Hog Production, where NTA provides additional income for tobacco farmers in hog production. The project includes value-adding/processing, where it operates the Kadiwa ni Ani at Kita Food Processing Plant;

Gulayan at Manukan sa Barangay and Vegetable Seed Distribution Project, also in response to food security during the Covid 19 Pandemic, where tobacco farmers will be given free inputs on the production of various vegetables and poultry;

# II. CLIMATE CHANGE ADAPTATION AND MITIGATION MEASURES/DIGITAL AGRICULTURE

- Renewable Energy Farm Project and Restoration of Ecological Integrity of Tobacco Growing Regions, activities will include the annual Synchronized Tree Planting per province and the Beema Bamboo Production Project with the aim of producing alternative source of materials for curing and in the future utilize the biomass for possible conversion to ethanol and other fuel forms;
- Development of Facility Maps in Tobacco Producing Areas aims to develop NTA projects and tobacco related activities and facilities map for stakeholders of the tobacco industry; to generate a web map application, story map and operations dashboard embedded to NTA website;
- 3. Monitoring of Soil and Water Quality shall generate information on the fertility and salinity status of different tobacco growing areas to be presented as soil fertility and chloride maps.

## III. MOBILIZATION AND EMPOWERMENT OF PARTNERS TO ATTAIN SCALE/ PROFESSIONALIZATION

Farmers' Organizational Development, to include continuing registration of farmers, strengthening farm clusters, trainings for cooperative officials and members, organizational development and livelihood assistance, to enable the farmers to become self-reliant, food secured and active partners of development;

## IV. GLOBAL TRADE, EXPORT DEVELOPMENT AND PROMOTION

- Continuing Research and Development, and implementation of pioneering ventures (the other industrial uses of tobacco), involves various researches on the enhancement of technologies and profitability of the production of tobacco dust, tobacco handmade paper and tobacco leaf extracts as pesticide for vegetables, fruits and ornamentals, among others;
- 2. Quality Assurance for Tobacco Leaf and Manufactured Products, will concentrate in the provision of laboratory services that to test the quality of soil, water, fertilizer and leaf tobacco, including the continuing study and monitoring of physical and chemical quality of cigarettes, as an input to continuing technology adjustments, standards formulation and effective regulation enforcement and compliance;
- 3. Market Research and Development includes research and assessment on the local tobacco industry, situation/trends of the international market and trade promotions thru participation in trade exhibits.

#### V. EASE OF DOING BUSINESS

Regulatory Services covers the monitoring and issuance of licenses on the trading of leaf, on the implementation of trading centers/tobacco buyers of the

harmonized grading system of tobacco, as well as the bi-annual conduct of Tripartite conference on floor price determination. The processing of import/export and transhipment licenses are done thru the **Tradenet**, an online system developed by the Department of Finance to facilitate processing/approval.

## VI. STRATEGIC COMMUNICATIONS

Communication Support Program involves the provision of information and education materials for the stakeholders especially the tobacco farmers, in the form of technoguides/technocalendars, newsletters, video production, radio programs (OMT) and other forms of social media;

## VII. PROFESSIONALIZATION

- Institutional Development Programs include Human Resource Development activities, capability trainings for the agency's personnel and improvement of facilities, buildings, and acquisition IT software and hardware;
- 2. Mobility Support Program for Extension Workers, aims to provide the facility loan for TPROs and Agriculturists for them to be able to purchase motorcycles to be used in their field monitoring activities;

# RELATIONSHIP TO NATIONAL DEVELOPMENT PLAN, POLICIES AND PRONOUNCEMENTS

The above programs, projects and activities are supportive of the the Department of Agriculture's vision and priorities and Philippine Development Plan (PDP) government that lay down the foundation for inclusive growth, a high trust and resilient society, and a globally-competitive knowledge economy resulting to the reduction of inequality in economic opportunities thru increasing access to economic opportunities of small farmers and fisherfolk, particularly access to value chain, innovative financing, land and water resources and technology. It is likewise in support of the new normal activities in agriculture and fisheries.

The Philippine Tobacco Industry has the following significant contributions to the country's economy:

It provides livelihood and sustenance to some 1.7 million people, including the more than 400,000 farmers, farm workers and the members of their family;

It earns for the national coffers some PhP150 billion in taxes a year, with the excise taxes from locally manufactured Virginia-type cigarettes alone reached PhP147 billion and PhP148 billion in 2019 and 2020, respectively per R.A. 11346, as amended;

From the excise tax collections in the same period, the industry brought in some PhP74 billion per year to the Universal Health Care and Health Enhancement

> Program of the Government thru the Philippine Health Insurance Corporation

(Philhealth) and Department of Health;

Some PhP27 billion will be plowed back to tobacco-growing local government units (provinces, municipalities and cities), which they can use for their priority programs and projects, pursuant to R.A. 7171 and 8240; and,

> The industry also earns US\$550 million, equivalent to PhP29 billion, exportation

of unmanufactured and manufactured tobacco.

### TOTAL BUDGETARY REQUIREMENT FOR CY 2022

For the effective implementation of its programs and projects for the year, the NTA will need a Total Agency Budget of One Billion, Three Hundred Forty-Four Million, Six Hundred Ninety-Three Thousand Pesos only (PhP1,344,693,000.00), which will be spent for Personal Services (PhP295,070,000.00), Maintenance and Other Operating Expenses (PhP504,894,000.00), Capital Outlay (PhP61,150,000.00), Investment Outlay (PhP287,985,000.00) and Accounts Payable (PhP195,594,000.00).
