

WHEREAS, the National Tobacco Administration (NTA) is mandated to administer and regulate the tobacco industry;

WHEREAS, the NTA is mandated to enforce the 2018 Revised Rules and Regulations Governing the Trading and Redrying of Locally Grown Leaf Tobacco, particularly, the documentary requirements namely; duly notarized Purchase Commitment (NTA-RD-F-014 rev 02) per Buying Station, per Province/Branch Office and by Tobacco Type, with Performance Bond (refers to the cash bond posted by the WTD / BS to guaranty the performance of its obligations under the purchase commitment) to those BS / WTD without a Marketing Agreement; and

**WHEREAS**, it is imperative for the NTA to enforce Rule 3 of Regulation III-Requirements To Support The Application For License and Authority To Buy Leaf Tobacco, as provided in the 2018 Revised Rules and Regulations Governing the Trading and Redrying of Locally Grown Leaf Tobacco.

**NOW**, **THEREFORE**, by virtue of the powers vested in the NTA, the deadline set for the **submission of Purchase Commitment**, starting CY 2022 onwards, shall be as follows:
